1. Conversion Fee, *difference in entrance fees and **Security Deposit is payable. All Fees are subject to prevailing GST.
2. Conversion to Basic Membership (from Full Ordinary / Associate Membership):
 - a. There must be a minimum of 1-year term remaining at the time of application for conversion.
 - b. Ordinary / Associate Members who convert their membership to Basic Membership will have their membership terms doubled. This is calculated based on the balance term remaining in the membership. Refer to the table below:

- c. Conversion Fee of \$100 (excl. GST) and **Security Deposit of \$300 (where applicable) are payable.
3. Conversion to Full Ordinary / Associate (from Basic Membership):
 - a. Basic Members may convert to Full Ordinary / Associate Membership by paying the difference between the prevailing entrance fee for Ordinary / Associate Membership and the pro-rated fee paid earlier for Basic Membership.
 - b. Entrance Fee is payable for conversion of membership is calculated based on the following:
 - Prevailing Ordinary / Associate Membership Entrance Fee minus *Pro-rated Entrance Fee paid for Basic Membership.
 - For example:** Convert to 3 years Ordinary Membership from 5-year term Basic Membership.
Prevailing Entrance Fee for Ordinary Membership = \$2,880
Entrance Fee paid for Basic Membership = \$2,400
Remaining Basic Membership Term = 3 years
 - Entrance Fee Payable for conversion to 3 year Ordinary Membership = \$2,880 - \$1,440* = \$1,440
 - c. Conversion Fee of \$50 (excl. GST) and **Security Deposit of \$300 (where applicable) are also payable.

5. The Club reserves the right to reject any application without assigning any reason or whatsoever.
6. The Club reserves the right to amend the Terms & Conditions without prior notice.

Please note that the use of NSRCC's credit facility has a charge limit of \$2,000 (for 10-year term Ordinary / Associate Membership and above) or \$1,000 (for Ordinary / Associate Membership up to 9-year term and Ordinary / Associate (Basic) Membership). An admin fee of 2% of the outstanding amount or \$3 per month, whichever is higher will be levied should your account not be settled within 30 days of the first billing. The use of credit facility will be suspended until your account has been settled.

- ii. **After** the 15th day of the month will be converted the month after next, i.e. application received **on** or **after 16Jan** will be converted with effect from 1 Mar.

* Pro-rated Entrance Fee paid for Basic Membership = $\frac{\text{Basic Membership Entrance Fee} \times \text{Remaining Term}}{\text{Basic Membership Term}}$

** Payable if applicable. Security Deposit is a compulsory deposit which serves a deposit for your internal credit facility. It will be refunded when your membership term ends.

Membership Eligibility (Membership Category after Conversion):

Eligibility for each membership category is considered at the time of application for conversion. Ordinary category is open to NSF/NSmen. Associate category is open to ex-NSmen.

Notes on Basic Membership:

Basic Members will be able to enjoy full access to the resort's social facilities, incl. the Executive Par 3 Course and Driving Range, at all times. However, they will be able to make bookings and play golf on the main course (SAFRA Resort's 27 holes and Kranji Sanctuary Golf Course's 18 holes) on weekdays (excl. Public Holidays) only. Basic Members will not be able to participate in golf tournaments held on weekends and Public Holidays but will be able to do so if the tournaments are open to the public (non-members' rates is payable). If they golf during weekends and Public Holidays, they must be signed-in by Ordinary / Associate Members at the following rates:

Principal Members – SAFRA Members' rates.

Spouse / Junior Members – Visitors' rates.
