TERMS & CONDITIONS

1. The Extended Junior Membership (“Junior Membership”) is opened only to **sons** (existing Junior Member) (of existing National Service Resort & Country Club (“NSRCC”) members) who are above 21 and below 25 years of age and pursuing full-time study at an Institute of Higher Education.
2. Please submit the following with this application form:
 - a. The Junior’s letter of admission from the Institute of Higher Education, indicating his duration of study.
3. The extended membership term (“Membership Term”) of a Junior Member will have to cover the duration of his study and will expire the moment he reaches 25 years of age or at the end of his higher education or upon expiry of the Principal Membership term, whichever is earlier.
4. Entrance fee equivalent to \$10 per month shall be payable in advance per Junior Membership extended. Hence if the membership term approved is 3 years and 4 months, the total entrance fee payable will be \$400, i.e. \$10 x 40 months. Fees are subject to prevailing GST. The membership term shall commence only after the receipt of entrance fee.
5. In the event that the Principal Member applies for Absent Membership:
 - a. The Junior Membership shall be withdrawn. The pro-rated entrance fee paid earlier shall be refunded accordingly; and
 - b. The Junior Member may apply to reinstate his membership upon expiry of the Principal’s Absent Membership, subject to fulfillment of requirements stated on paras 1 to 4 above.
6. If the Principal Member or Junior Member terminates his membership upon commencement of the Junior membership term, any entrance fee(s) paid earlier shall be forfeited.
7. Members are subject to the provision of the Constitution, Rules, Regulations and Bye-laws of the Club.
8. The Club reserves the right to reject any application without assigning any reasons whatsoever.
9. The Club reserves the right to amend the Terms & Conditions without prior notice.
